

CRITERIA AND PROCEDURE FOR THE EVALUATION OF THE APPLICATION FROM CANDIDATES FOR FENG EXPERT STATUS

Evaluation criteria:

I. STAGE I – formal verification of the applications

As part of the first stage of evaluation, the following shall be verified:
(in accordance with the enclosed declarations provided by the candidate)

- 1) the statements submitted with the application in respect of:
 - a) enjoyment of full public rights,
 - b) full legal capacity,
 - c) not having received a conviction by a final judgment for an intentional offense or for an intentional fiscal offence
 - d) consent to the inclusion of my personal data in the list of candidates for experts of FENG and for the processing of personal data disclosed by the candidate for experts in the process of creating and maintaining the list of candidates for experts, for the purposes of participation in the selection of projects and the performance of the institution's obligations under the Implementation Act,
 - e) not being in an employment relationship with the Intermediate Bodies and the FENG Managing Authority.
- 2) the areas of expertise identified by the candidate - defined in accordance with the NSS and SA of the NSS.

II. STAGE II – substantive verification of the Experts' qualifications

A. CRITERIA FOR THE EVALUATION OF CANDIDATES FOR SCIENTIFIC EXPERTS

OBLIGATORY CRITERIA

(verified on the basis of the applicant's declaration)

1. The candidate holds at least a doctoral degree.
2. The candidate possesses knowledge and proven professional experience in the field he or she is applying to evaluate.
3. The candidate has a proven track record of at least three years of professional experience in research leadership in the last five years or in the management of scientific units.

B. KRYTERIA OCENY KANDYDATÓW NA EKSPERTÓW GOSPODARCZYCH

OBLIGATORY CRITERIA

(verified on the basis of the applicant's declaration)

1. The candidate holds a university degree and at least an MA, M.Sc. or equivalent professional title.
2. The candidate has a proven track record of at least three years of professional experience in R&D or knowledge transfer in the business sector or business management in the last five years.

CLASSIFICATION OF EXPERTS' COMPETENCES

METHOD OF EVALUATION

A person applying for the status of scientific, economic or scientific and economic expert submits statements on the fulfilment of the formal and obligatory criteria for the selected expert type. In the case of an expert from both scientific and economic fields at the same time, it is necessary to fulfil the obligatory criteria for either type of expert. In order to confirm the fulfilment of the educational background or professional experience criteria, the FNP may ask for documents supporting the statements at any stage of the evaluation of the application for listing or before signing the contract with the expert. The FNP may also decide to waive the requirement to confirm the criteria with appropriate documents in circumstances where such validation can be obtained by other means, e.g. based on information in the publicly available People of Science database; in recognised research publication databases, e.g. Scopus or Web of Science, in business and company registers, etc.

An expert application is positively assessed by the Selection Committee if the formal verification of the submitted application is positive and all obligatory criteria for the type of expert selected by the candidate are met.
